

InsureMyTesla Launch Campaign

Terms and Conditions

Campaign Period

- 2. The Campaign shall commence from 1st Jan 2025 until 30th June 2025, both dates inclusive unless notified otherwise ("Campaign Period").
- 3. LGIB reserves the right to extend or terminate the Campaign at any time without prior notice.

Eligibility

- 4. The Campaign is open to all Tesla Sdn Bhd customers who finance their new Tesla vehicles via AmBank (M) Berhad/ AmBank Islamic Berhad (whichever is applicable), (hereinafter referred to as "Eligible Customers").
- 5. The Campaign is only applicable to Eligible Customers who apply and purchase Liberty General Insurance product known as InsureMyTesla a Private Car Electric Vehicle (EV) Comprehensive Policy ("InsureMyTesla") via LGIB's Call Centre (hereinafter referred to as "Participant").

Campaign Mechanics

The Participant will be entitled to enjoy up to 5% discount on basic insurance premium ("Campaign Offer") from LGIB when they purchase InsureMyTesla via LGIB's Call Centre during the Campaign Period. In addition to the Campaign Offer, Eligible Customers also enjoy a 10% direct rebate of the gross premium for their direct purchase of InsureMyTesla via LGIB's Call Centre. Employees of AmBank Group and LGIB are eligible to participate in the Campaign.
- 7. This discount is reflected in the quotation upfront.
- 8. The Campaign applies to policies (new applications) accepted by LGIB. LGIB shall not accept any policies under this Campaign after the Campaign Period has ended.
